First Silver Lake Master Plan Workshop

Approximately 150 people attended the first Silver Lake and Ivanhoe Reservoir Master Plan community workshop at John Marshall High School on March 27th, 1999. Mary Ann Kuk, a member of both the SLRA and CSSLR (Committee to Save Silver Lake's Reservoirs) provided a brief summary of the community's efforts to have a voice on the Reservoir property's appearance, operations and public accessibility. Next, Susan Rowghani of the Department of Water and Power presented a synopsis of DWP day-to-day and long term operations at the site.

After the introduction, the attendees were divided into subgroups at different stations for discussions. The 5 sub-groups represented the elements that will be addressed in the Master Plan. The elements are: Water Quality and Operations, Land Use, Landscape and Open Space, Traffic and Transportation, and Cultural Resources and Connections. Each sub-group discussed each topic for approximately 10 minutes and then moved to another station for the next discussion until all subgroups had an opportunity to comment on all of the elements. During the discussions comments were recorded in writing and placed on site diagrams or large pads.

There were many comments that came close to being consensus items and others that proved to have widely different opinions. Among ideas that came out of the first workshop were:

- · Walking/jogging paths around the reservoirs
- Bicycle lanes/paths around the reservoirs
- Improved landscaping of existing areas
- Preservation of the view
- Improvements to the dog park
- Making the streets safer for pedestrian traffic

Our next steps will be to take these comments and synthesize them into a Master Plan that will be supported by both the community and DWP. We will present concepts that illustrate possibilities that we know are desirable and attempt to achieve a balance on issues that are not so clear at point. This presentation will take place at the next Master Plan workshop on May 20th at John Marshall High School at 6:30 PM. See the announcement on page 5.

Gateway to Silver Lake 2000

So what is happening down at the Gateway to Silver Lake? Well, I'm glad you asked. After the ceremonial ground breaking back in January, David Bermudas, the brave soul who has been dealing with most of the work at this site, began removing the asphalt surface from the center medial on the east side of the freeway.

During the removal of the asphalt, the backhoe equipment ran into an obstacle beneath the earth that was below the asphalt. During another venture to the site to locate the holes to plant trees, David further discovered that the obstacle was much more than a localized nuisance. What was discovered? How about an old road, not just a an old road. No, David found 8 inches of concrete that spans the entire width and length of the island. This is a formidable concrete obstacle that is 8 inches thick, 13 feet wide, and 210 feet long.

What was found is not a continuation of the road we drive daily. It's surface is lower than the surface we use today and means that it is very old and hard concrete that dates back to the 1920s. The current Silver Lake Boulevard was constructed shortly after World War II when the Hollywood Freeway was built.

Funds Budgeted for Glendale Corridor

The final meeting of the Glendale Corridor Advisory Committee took place in March 1999 and the \$3.75 million of funds were allocated to various improvements. The allocation breaks down as follows:


- \$1.5 million was allocated to transportation improvements along Glendale Boulevard. These include installation of additional signals, increasing pedestrian crossing times, and improvements at the intersection Glendale, Alvarado and Berkely.
- \$1 million was allocated to match the \$12 million allocated by the federal government for the development of a park at the terminus of the Glendale Freeway. An additional \$3 million of local matching funds will be necessary to obtain the full \$12 million from the federal government.
- \$750,000 was budgeted for streetscape improvements including landscaping, tree planting, bus stop lighting, public art, and sidewalk repair.
- \$500,000 will be spent on neighborhood traffic protection measures, also know as "Traffic Calming". These funds will be used to limit the amount and velocity of traffic cutting through neighborhoods. Measures include installation of speed humps, small traffic circles, stop signs, turning restrictions etc.


Silver Lake should receive a portion of the funds due to the impact of the freeway terminus on the community. The impact includes traffic exiting the Glendale Freeway on Fletcher and San Fernando and cutting through Silver Lake to avoid congestion on Glendale Boulevard and rush-hour backups on the Glendale Freeway. The Silver Lake Residents Association is currently working with the MTA and Los Angeles Department of Transportation to identify specific improvements which can











Midge Fly Spraying

Very soon, annual Midge Fly Spraying will begin again in Silver Lake. Spraying will be twice weekly for at least May and then once per week (on Thursday only—the same day as trash pick up for only ONE early morning intrusion) for the balance of the summer unless the weekly monitoring (adult flies and fly larvae collected in biotraps) indicates the need for more frequent spraying.

The DWP applies a 50% solution of Malathion Emulsifiable Insecticide to the trees and shrubs around the reservoir, except near the Neighborhood Nursery School and the West Side Eucalyptus grove near Hawick where the Great Blue Herons are nesting. Malathion is not highly toxic to humans or pets, does not persist long in the environment after being applied, and presents no long-term hazard. It is approved by the State of California Department of Health in this formulation for this problem.

Chlorine Depot Status

The new chlorine depot (located at Los Angeles Reservoir) is nearing completion and the blue 50 gallon tanks will be moved from Silver Lake soon. This change of location will greatly decrease the truck traffic at the Silver Lake/Ivanhoe gate near the Neighborhood Nursery School. This project was part of the 10-year long Mediation Process with the DWP to remove functions that would be better headquartered elsewhere. What to do with the remaining concrete platform will be addressed in the Master Plan.

The Eagle Has Landed!

On April 16, an immature bald eagle landed in a tree, not more than 20' away, on Kenilworth. Spotted by Sharon Flanagan on her morning walk, this sighting was the first reported in a number of years. Reported in this newsletter in March 1992, and again in December 1997, there aren't a lot of bald eagles in the area. It is always exciting to birders to see unusual bird in the local neighborhood. We get used to the unusual; even Great Blue Herons nesting in the Eucalyptus grove on West Silver Lake Drive at Hawick for the past few years is now ho-hum. Bald Eagles (even immature ones without the white head—which appears only after 4-5 years) can be distinguished from the frequently seen Red Tail Hawk by several distinguishing characteristics. The Bald Eagles are bigger (36" vs. 22" tall) with a wing span of 70-90" vs. 50" for the hawk. So keep an eye out for this treat and if you see two, there may be a nest. Corralitis Resolution

A final resolution regarding the use of the old Red Car line right of way between Corralitis Drive (near the Glendale Freeway) and Fletcher Drive appears to have been achieved. The open area of land has been argued about since 1981 when the first development project was proposed. In 1997, a new owner agreed to wait for the community to raise funds to purchase the property for a park. However, funds were not forthcoming and in January, 1999, the developer initiated the planning process to subdivide the land for sale and development.

There was a community meeting on March 2, 1999 to review all the possible alternatives for this property. Given the fact that there were no available money to make the whole parcel parkland, those attending the meeting suggested a alternative option. The developer would develop the two ends of the property and have the middle section developed as a park. This plan provides for 4 lots for single family residences at the Adelbert Avenue end, and 6 lots for development at the Corralitis Drive end.


In April, 1999, the Santa Monica Mountain Conservancy voted to take on preparation and supervision of the middle section of the property as parkland. Funds for maintaining the parkland will come in part from an assessment on the new lots.

The important end result is that nearly 70% of the property will be preserved as a park for use by residents.

"Thank you for taking care of our community. I feel fortunate to live here. Our family moved here from Orange County 10 years ago and love it."

"I saw a street vendor (with a cart) on Silver Lake Blvd on Sat, April 17 by the car wash. In my view, these vendors symbolize a poor and decaying neighborhood and, as such, the City Ordinance prohibiting street vendors except in designated areas should be enforced." [Ed. Note: Phone our LAPD Senior Lead Officer at 213/485-4079 with the day, time and location of these illegal vendors, regular reports on this violation will improve enforcement).

"I am requesting that the dog park be moved to another locale—Elysian Park or Griffith Park, where there is more acreage and more parking and off a main street of traffic. Evenings and weekends are horrific on Silver Lake Blvd." [Ed. Note: We, too, are concerned with the traffic hazard this very popular dog park is creating. Extensive discussion and possible solutions will be presented with the Silver Lake/Ivahoe Reservoir Complex Master Plan—see article elsewhere in this Newsletter. Also, with the demonstrated success and popularity of this off-leash dog park, let the Dept of Recreation & Parks new General Manager, Ellen Oppenheim, (213/485-5555) know that the City needs more of these facilities.

"Paving- Silver Lake Blvd-is long due, now.....could it be possible to ask people between Berkeley and Effie to stop dumping discarded furniture, mattresses, etc. on Randall St (not an alley). At present time, two old broken trash cans were hauled to the north end of the 7-ll store and abandoned there. Also trash cans left out after they are emptied for days gives the area a seedy look. We want to keep Silver Lake nice and clean! Thanks" [Ed. Note: We agree, Board members call on abandoned cars (those parked over 72 hrs. They need color, make, license and location (800) 222-6366 and abandoned stuff (800) 611-2489 nearly daily. Won't you keep these numbers in your car and help us keep Silver Lake looking tidy].

"I am pleased to live in Silver Lake since 1974 and appreciate the activities of the SLRA and CSSLR on behalf of the community. A problem affecting many areas of L.A. is the slum-like appearance caused by the trash cans left out at the curb in violation of City Ordinances. City inspectors will issue warnings if complaints are made, but it is a lengthy and wasteful approach. Could the SLRA send an "official" notice letters to the irresponsible property occupants if residents complain to SLRA?" [Ed. Note: This is a City-wide problem and the most often heard complaint in the neighborhood. Any one willing to take the lead on a committee to work on this problem?]
